- We understand that this application is subject to acceptance by the Proprietor who reserves the sole right to decline any application without assigning any reason. If our application is unsuccessful, any monies paid by us shall be refunded to us without any interest or any other form of compensation. In addition, we understand that the Proprietor has the full discretion to offer future memberships in such categories and in such numbers as the Proprietor deems fit.
