In addition, I understand that the Proprietor has the full discretion to offer future memberships in such categories and in such numbers as the Proprietor deems fit.
- I understand that this application is subject to acceptance by the Proprietor who reserves the sole right to decline any application without assigning any reason. If my application is not accepted, any monies paid by me shall be refunded to me without any interest or any other form of compensation.
- I am fully aware and agree that the right to utilize and enjoy the facilities and membership of the Club and The Legends Golf & Country Resort in Johor Bahru do not confer upon me any rights, title or interest in any property or assets owned by the Proprietor or in the facilities or the assets of The Legends Fort Canning Park (the "Club") as well as The Legends Golf & Country Resort in Johor Bahru.
